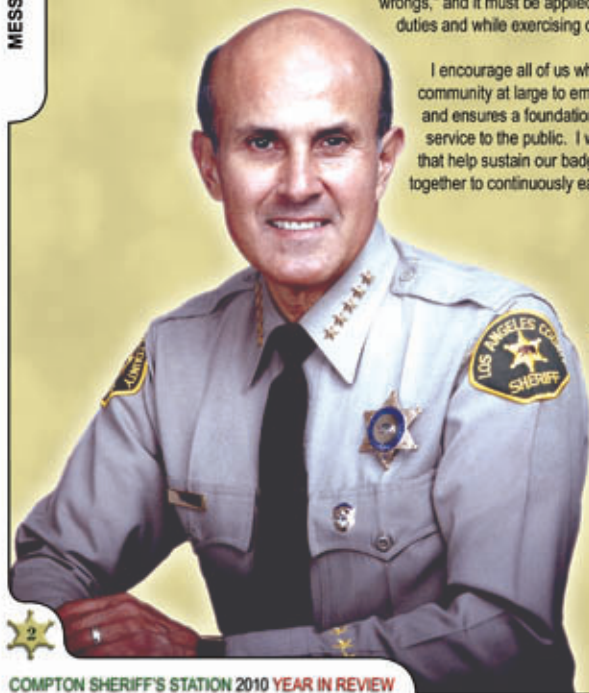
Message from the Sheriff

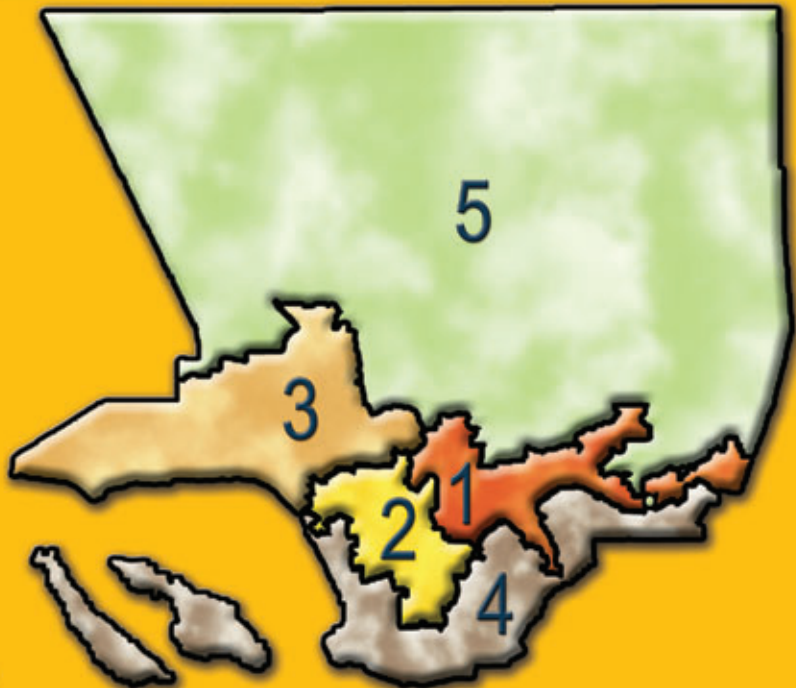

FOREWORD

At the stroke of midnight on September 17, 2000, the City of Compton was introduced to a new level of service. As the old Compton Police Department gave way to the new Compton Sheriff's Station, Compton Police Officers traded in their blue uniforms for the now ubiquitous tan and green. Ex-Compton police officers, veterans of the streets of Compton, partnered up with fresh deputy volunteers to continue the arduous task of patrolling the harsh streets of Compton.

It is often said that in the early days of Compton Sheriff's Station, you could always tell who was who because you would always see confused faces trying to work with Sheriff's equipment while at the same time you would see confused faces trying to read maps.

It is in this context, that Compton Station increased the estimated service patrol hours to 141,692 annually from the previous 127,410 annual patrol service hours provided by the Compton Police Department and began to turn the city around from a crime ridden haven for criminals into a community whose parks are now filled with playing children and residents can now walk the streets without fear of becoming victims.

In addition to the increase of patrol deputy staffing levels, the City received additional support in the form of specialized units, including the following investigative support units: Special Enforcement Bureau and K-9 Units, Safe Streets Bureau - Gang enforcement specialists, Traffic Services Detail, Specialized Detective Units - Homicide, Arson-Explosives, Forgery-Fraud, Family Crimes, etc.

Of those units described above, Operation Safe Streets, Gang Enforcement Team and Narcotics Bureau have personnel assigned on a full-time basis to Compton Station, as a supplement to patrol personnel. Adhering to the Sheriff's Department's "Tradition of Service," two teams were formed to respond to the needs of the Compton Community: the Community Relations Team and the Special Assignment Team.

Now as we celebrate 10 years in Compton, this publication is dedicated to all those who have volunteered to serve this community, whose efforts have touched so many lives and helped improve the quality of life in Compton.

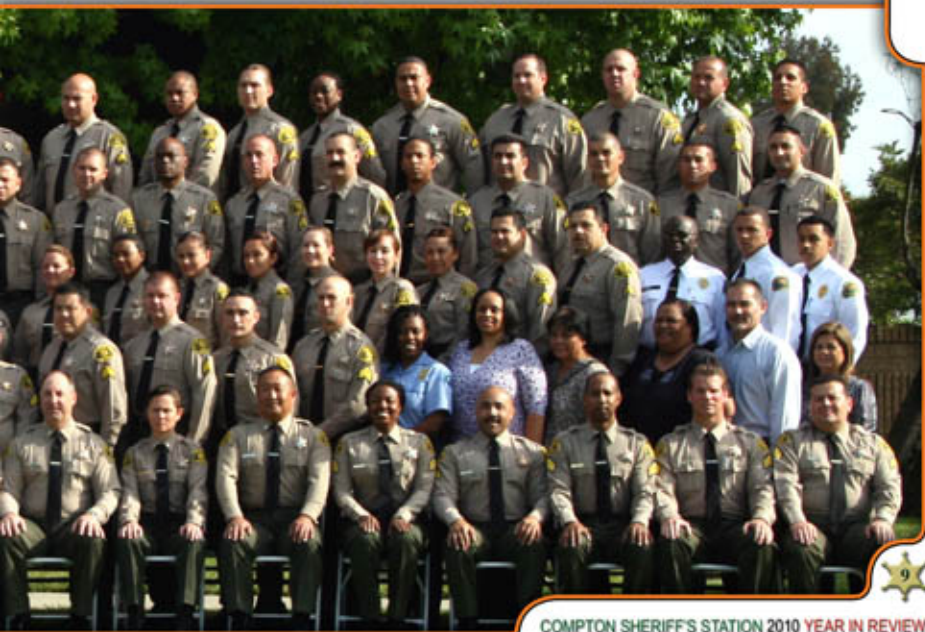

Traffic



2010 was an exciting year for the traffic office.

The Office of Safe Transportation Research and Education Center (SafeTREC), provided the funds to perform 24 Driving Under the Influence Check Points throughout the city.

The operation has some colorful job titles such as the "Pit" assignment. This group of deputies, explorers, volunteers and parking control officers fill out the paperwork necessary to proceed with the criminal prosecution of violators. Deputies in patrol cars and on motorcycle are available to ensure that persons who attempt interfere with the check point receive attention. The team also has a staff that provides secretarial data input. The team was responsible for the arrest of persons driving under the influence and driving without a valid license. Seatbelt and other violations are enforced. The work is rewarding knowing that this early intervention improves public safety.

The traffic office also received new equipment and training to assist patrol deputies with traffic investigations. Congratulations to deputies Ernesto Valdez and Marco Miranda who successfully completed the Peace Officers Standard and Training in Basic Traffic. Deputies Tifani Stonich and Allison Holland completed the Drug and Alcohol Recognition Training more commonly known as "DART". Traffic investigator Detective Lennig completed an advanced course in traffic investigation. Deputy Wilson and others received training in commercial enforcement.

The traffic office in cooperation with the City of Compton completed a new speed survey. This survey ensures that the speed limits set in the city are in compliance with the State of California and ensure public safety. Road improvements have continued as part of the City of Compton commitment to public safety. Compton Sheriff Station will continue to work to make other improvements to provide for the needs of the community.

The Compton Community Relations Team is Compton Sheriff's Station's liaison to the community. Under their auspices, many community outreach programs are overseen while others have been pioneered. This team is one of the most active in the Sheriff's Department, participating or hosting many events throughout the calendar year as well as continuing to enhance its services to the residents of Compton. Many of the programs and events featured in this book including the design layout of this publication have been directly overseen by the Community Relations deputies. Featured below are some of our collaterals.

Reserves

Currently, we have eight reserve deputies who perform many duties; from patrol operations to intervention to special assignments such as prostitution stings, gang enforcement, etc.

Explorers

Compton Sheriff's Explorers are community youths who volunteer at Compton Station with various duties such as traffic control at large events, community clean ups, and assist deputy personnel with various assignments at the station. Many have gone on to serve with our armed forces, law enforcement, various successful professional careers, and are currently attending colleges and universities.

Volunteers

We have a volunteer corps that assists us in every day operations. Our Volunteers On Patrol also known as VOPS, patrol regularly and report back to our dispatch center any noteworthy incidents. Other volunteers assist us with community events such as the Community Camp-Outs, Holiday events, Coffee with the Captain, etc. Others help out at our secretariat with the filing of paperwork and putting packets together.

Block Clubs / Neighborhood Watch

The Compton Station area has many active Block Clubs/Neighborhood Watch Programs, which sponsors town hall meetings, where our Community Relations staff participates by disseminating important information.

Parole Assistance

We have recently partnered up with Century Sheriff's Station and Faith Inspirational Missionary Baptist Church to launch a program called "Project Restoration" for the purpose of facilitating parolees integration back into society.

Interventions

Compton Station conducts the Youth Mentoring Referral Program. This program provides referral and counseling assistance to parents and youth who are experiencing behavioral problems. Typically these youth are referred to the Department's Vital Intervention and Directional Alternatives (VIDA) program.

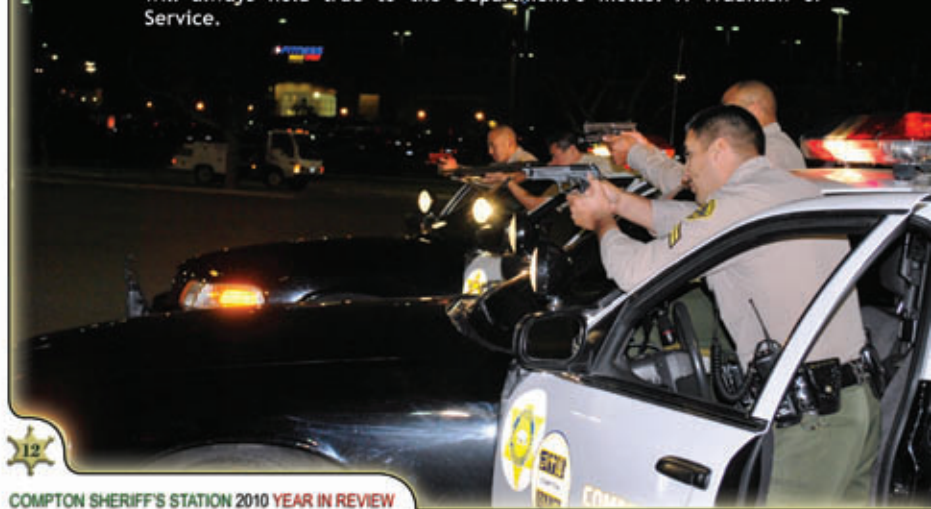
FIELD TRAINING OFFICERS



Although newly assigned deputy sheriffs are referred to as "patrol trainees," none of them are rookies. Following their Academy training, they all work a number of years in the Sheriff's Department Custody or Court Services Divisions. Once they satisfy this commitment, they are allowed to select their patrol assignments. This means each trainee is a volunteer, and chose to work Compton Station.

The relationship between the field training officer (FTO) and the trainee is one of the most important relationships between two individuals that exists within the Sheriff's Department. Future service to the community, to a large extent, begins with the lessons and examples provided by the FTO and the trainee's effort to learn and develop.

Compton Station's FTO's are among the best the Sheriff's Department has to offer. Trainees who successfully complete the training program here are highly qualified patrol deputies, instilled with service oriented policing techniques that make them outstanding leaders in the community they serve. The FTO's efforts guarantee our deputies will always hold true to the Department's motto: A Tradition of Service.



FIELD OPERATIONS

FIELD OPERATIONS

The Compton Station patrol area is divided up into 41 different reporting districts. The city of Compton accounts for 33 of the reporting districts and the surrounding unincorporated Los Angeles County communities of East Rancho Dominguez, Gardena, and Rosewood account for the remaining nine.

Compton Station patrol personnel is comprised of 78 dedicated deputies who work all holidays, weekends, and in any weather 24 hours a day, 7 days a week for the community they serve.

Compton Station patrol personnel are tasked with answering calls for service and conducting proactive enforcement, with an emphasis on community policing and problem-solving approaches. The personnel that work patrol at Compton Station face unknown and unexpected danger on a daily basis in a diverse and challenging environment. Patrol personnel are likely the first and often the only encounter the public has with law enforcement.

Compton Station patrol personnel have a great deal of responsibility, including: enforcing federal, state, county and city statutes and ordinances; conducting initial investigation of reported or observed crimes; recording and preserving evidence found at a crime scene; initial investigation of reports of missing, found or unidentified persons; responding to scenes of emergencies; arresting on-sight violators; recovering property; investigating complaints received from the public; patrolling to prevent and suppress crime; and preparing reports of incidents investigated or observed.

During 2010, Compton Station patrol personnel responded to and investigated more than 82,000 calls for service, wrote 22,555 reports, and made 3,691 arrests. Due in part to the hard work of patrol personnel, Compton Station realized a 7% decline in overall crime from 2009 to 2010, including a 39% decrease in homicides, and 19% decline in armed robberies.



DETECTIVE BUREAU

Our detectives employed the use of a variety of resources to solve cases. Surveillance operations, undercover stings and tips from the public are just a few. The sixteen detectives and three sergeants assigned to the detective bureau are dedicated professionals committed to providing the highest levels of service to the communities we serve. Their hard work and effort coupled with the community's support has resulted in many successes.

Our mission to educate community members and encourage their participation in our effort to make our neighborhoods safe continued throughout 2010. Through our partnership with the Compton Bulletin, monthly activity reports and crime prevention information was disseminated to the residents of Compton. We are anticipating greater community involvement as we work to increase community awareness of the "Los Angeles Regional Crime Stoppers" program. The program allows community members to inform our staff of suspected criminal activity while maintaining anonymity. With our continued enforcement efforts and the communities involvement, we anticipate further reductions in the crime rate and safer neighborhoods for our residents.

FIGHT AGAINST GANGS

There are more than 71 gangs in the city of Compton with more than 2843 documented gang members who reside in the city. Gang issues in the city are numerous, longstanding, and thus pervasive. Compton is the birthplace to many of the most notorious and violent street gangs in America. To combat gang violence, the Los Angeles County Sheriff's Department utilizes the Operation Safe Street's Bureau.

OSS is a program of selective enforcement aimed at combating the criminal activities of targeted hard-core gangs and, at the same time, moving to discourage followers from continuing in gang activities.

Sheriff's personnel assigned to the Safe Street's Bureau are experienced in all phases of street gang activities, and work in both uniform and non-uniformed capacity. This unit is responsible for investigation of crimes committed by targeted gang members. OSS works in conjunction with other law enforcement agencies, probation, parole, and district attorney's in their endeavor to prosecute gang members for their criminal activity.

The philosophy of OSS is to vigorously prosecute and incarcerate the hard-core violent gang members of selected target gangs. Target gangs are chosen by the number of members, the amount of violence, and their geographical area, in relation to other gangs in the station area.

The OSS program directly attacks the total gang problem by dealing firmly with hard-core target gangs and giving them the highest enforcement priority. OSS has proven to be an effective pro-active method of preventing gang violence as well as apprehending, and convicting serious gang offenders.

Since the Los Angeles County Sheriff's Department assumed law-enforcement responsibilities in the city of Compton, gang violence has seen a dramatic decrease with many significant convictions of local gang members being sentenced to more than 5,875 years in prison.

Many Compton gang members have been sentenced to life sentences with multiple local members being sentenced to the death penalty for particularly heinous crimes.

During 2010, gang crime in Compton has dropped dramatically. Compared to 2009, gang related homicides were down 54.84 %. Shootings were down 32% during the same time frame. Although this is an enormous achievement, we continue to see the devastating effects of gang violence in our community. The Los Angeles Sheriff's Department and Operation Safe Street's Bureau reaffirms its commitment to reducing gang violence in the city of Compton and will utilize all available resources to assist in our efforts.



GATEWAY TOWNE CENTER

The Gateway Towne Center located at Alameda Boulevard north of the 91 freeway has been open for business since October 2007. Owned by Prism Realty Corporation, new state of the art cameras have been added to our ASAP network to view activity at TGIF restaurant. Partly based on an incident last year the cameras were installed. To date, there haven't been any significant incidents at the restaurant.

The current Gateway detail still consists of 4 deputies and two security assistants. Our presence at the center has greatly reduced criminal activity and serves as a model for shopping centers to emulate. A community policing approach is used at the center and personnel assigned to the detail meet regularly with the property manager, on site security and tenants to address security concerns and provide training. Target Corporation and our station hosted "National Night Out" at the center which was very well attended by the community. During peak times, such as weekends and Christmas holiday periods the city of Compton hires extra personnel to address security needs. During last year's holiday deployment period there weren't any significant incidents at the shopping center. Residents of Compton can rest assured that the crime rate at the shopping center still remains low just as it has been since its opening.

Prism Realty has plans in the near future to expand the center and add more stores for the shopping enjoyment of Compton residents and the like.

During last year 125 arrests were made at the shopping center which included 104 felony arrests.

Compton Special Assignment Team



The Compton Sheriff's Station Special Assignment Team is made up of one sergeant and six deputies. This Team of highly energetic and motivated deputies is undoubtedly the backbone of Compton Sheriff's Station.

The team's main objective is to enforce laws to improve the "quality of life" issues in the City. In addition to "quality of life" issues, the team is tasked with coordinating various operations, including: Prostitution Stings, Sex Offender Registration Enforcement, Truancy Sweeps, Gang and Graffiti Enforcement, Housing Urban Development Sweeps, Abateements, Bicycle Enforcement, Alcohol Beverage Control (ABC), Violations, Enforcement of Selling Alcoholic Beverages to Minors, Illegal Vendor Enforcement, Minibike Enforcement, Stolen Vehicle Stings, City Council Election Security, Vital Intervention Prevention and Education Response programs, Compton Unified School District "Operation Safe Passage," Station Active Shooter Training, Special Holiday Enforcement (Fourth of July Fireworks Enforcement, Compton Jazz Festival, Compton Gospel Festival, Cinco De Mayo Festival and Juneteenth Celebration), Community Outreach Operations and Area Citizen's Surveys.

The Special Assignment Team also assists other station units (Narcotics Bureau, Detective Bureau, Operation Safe Streets Bureau, Station Operations Bureau and the Office of Community Relations) with their various duties and operations. The Special Assignment Team additionally assisted Homicide, Major Crimes Bureau, Commercial Crimes Bureau, Trap, Special Victims Bureau, Parole and Probation Departments. Team members had the opportunity to write and execute search warrants. Additionally, they worked together with the District Attorney's Office where they prepared and filed cases with the local courts.

Recently, team members Deputies Carl Adams, Scott McCarthy and Raul Briones left the team to pursue other career opportunities at the station.

It is the continued philosophy of the Compton Station Special Assignment Team to perform at the highest achievable standards and within the Department's Mission Statement, Core Values, and Creed for the valued citizens of Los Angeles County and The City of Compton.

Professional Staff

The Professional Staff's primary responsibility is to assist the public with various administrative requests, share information with other agencies, and provide technical support to our station personnel. The staff member's pride themselves in providing the best service possible to the citizens of Compton.

During 2010, Compton Station professional staff processed and maintained approximately 23,555 reports. Despite another year with massive budget cuts, and shortage of personnel, Compton Station professional staff joined together with other Department professional staff and were able to index and process over 1800 reports on a monthly basis. Compton Station's Records Section is the Hub and the pipeline where all manner of police records are maintained.

The key element to recordkeeping is the ability to retrieve information quickly and efficiently to be utilized as a resource and investigative tool. The Department depends on the data entry information that is reliable, accurate, complete, and timely.

The accuracy of this information allows law enforcement personnel the ability to update, share, and access critical data via one centralized database, enhancing communication and improving the efficiency of information retrieval. In addition to their clerical duties, our Professional Staff members oversee the day-to-day operations of the station.

These duties include ensuring our vehicles are properly maintained and station supplies ordered, but that our facility is clean and well-maintained. Our Department relies heavily on the Professional Staff for all that they do.

Reserves

RESERVES



Reserve Deputy Sheriffs are utilized to supplement the Los Angeles County Sheriff's Department law enforcement manpower. Like full-time deputies, reserve deputies are professionally trained and duly sworn law enforcement personnel.

In most cases, Reserves are assigned to the same duties as full-time deputies. Since Reserve Deputies have the same powers of arrest as full-time deputies they are required by law to meet the same hiring, background, medical, and psychological standards as full-time Deputies.

Currently, Compton Station has eight (8) Reserve Deputy Sheriff's quite a change from the original one (1) in the fall of 2000.

Reserve deputies meet once a month. Compton Station Reserve Deputies participate in a variety of assignments such as uniformed patrol, D.A.R.T. (Directed Approach Reserve Team), Prostitution Suppression and Gang Enforcement.

Reserve Deputies have also been an intricate part in Community Relations assignments such as Mardi Gras Festival, Community Academy, Gifts for Guns and Cinco De Mayo Festival.

GENERAL REQUIREMENTS

- Be a United States Citizen.
- At the time of appointment, be at least 21 years of age (there is no upper age limit)
- Be a high school graduate or equivalent.
- Possess a valid California Class "C" Driver's License or higher.
- Be gainfully employed or a full-time student.

EXPLORER POST 1019



Our Explorer Program here at Compton started on February 10, 2001. Since its inception, the program has grown into 16 active explorers ranging between the ages of 14-19. One of the greatest benefits of the program is that it gives the youth the opportunity to become involved in learning the various aspects of law enforcement, and to be mentored by professionals who are committed to our community.

The Explorer program compliments our other youth programs, such as the Youth Activities League, in an on-going effort to provide direction and assistance to the youth of our community. Many explorers have become productive members of society. Some of have embarked in law enforcement careers, while others are currently serving in the armed forces.

Each participant must maintain above average grades, have good attendance in school, and demonstrate excellent citizenship skills. The explorers at Compton Station volunteer their time and effort to assist the city and county with various duties such as traffic control at large events, community cleanups, and assisting deputy personnel with assignments at the station.

VOLUNTEERS / VOLUNTEERS ON PATROL

Compton Station is very proud of its Civilian Volunteer Program. Civilian volunteers assist not only Compton Station but all the stations within the jurisdiction of the Los Angeles County Sheriff's Department.

The Civilian Volunteer Program is divided into two groups; Station Volunteers and Volunteers on Patrol (V.O.P.). Additionally, we accept up to four student interns from the local colleges who volunteer time to fulfill their required college credits.

The station volunteers will assist at various station functions and Community Relation Office events. The V.O.P. has to complete a series of training courses which allows them to assist in patrol functions.

Compton Station currently has a Civilian Volunteer force of twenty-nine volunteers, several of which have volunteered over one thousand individual hours since they started volunteering.

Station Volunteers are awarded the opportunity to work with deputies on D.U.I. checkpoints, ride-alongs, and other station functions. Additionally, they assist the station detectives and station professional staff with filing.

In 2009, we had volunteers assume duties at the front counter in the Gateway Towne Center's Sheriff's Sub-Station.

Volunteers On Patrol (V.O.P.) patrol the neighborhoods observing / reporting crime and nuisance abatement to our dispatch center. Our VOP's also conduct security checks on vacationers' homes.

DISPATCH CENTER



Our Dispatch Center operates 24 hours a day, 7 days a week. Our dispatch is staffed by a Watch Deputy whose responsibility is the overseeing of the operation, a dispatcher who assigns calls in accordance to response times and criteria, and two law enforcement technicians who receive the calls from the public and prepare them for review and assignment.

Our dispatch receives daily hundreds of calls for service. The calls are categorized in three different criteria according to the circumstances:

- Routine – Calls for service that are not emergent such as a report.
- Priority – Calls of serious nature.
- Emergent – Calls that require immediate response.

When calling our dispatch, you must be prepared with the following:

- Location of incident
- Description of incident
- Description of suspects
- Your name and call back number (You can remain anonymous or have the deputies contact you by telephone only).

- 911 (Emergencies only)

Captain Diane Walker following the footsteps of her predecessor Captain William Ryan, regularly meets with the community at the local coffee houses or bakeries to sip coffee and discuss how to continue to provide excellent service to the City of Compton and its unincorporated areas.

The overall purpose of this event is to invite the Compton community to an open forum with the captain.

Members of the community are given the opportunity to voice their concerns and ideas with the captain over coffee and pastries provided by the local Starbucks franchises and bakeries.

Community concerns were documented and followed up on by the Community Relations Office and/or patrol deputies.

Community Campouts

The Community Campouts identify neighborhoods with special problems that require special intervention. The community relations team meets with residents who are treated to hot dogs, hamburgers, soft drinks and chips while discussing solutions to the problems.

In many instances these encounters are just what the neighborhood needed. We have assisted several neighborhood in achieving a higher quality of life.

In one instance, loud parties from one house plagued the civility of a neighborhood as complaints mounted, nightly patrol requests were initiated. The community relations team organized a camp-out where all parties met and agreed to respect one another's peace.



In another incident, a neighborhood was beleaguered by a series of home burglaries, frustrated residents asked for help, which arrived in the form of a Community Campout.

We organized a neighborhood watch during the campout which now regularly reports any suspicious activity to the station, thus reducing the instances of burglaries.

COMMUNITY ACADEMY



The Community Academy is an eight week course, taught one night a week by Compton Sheriff's Station's deputy personnel. This program helps strengthen the line of communication between the community and the Los Angeles County Sheriff's Department. The course is presented in both English and Spanish to residents of the community. During the eight weeks course, students participate in role playing, receive an overview of the Los Angeles County Sheriff's Department, and learn about probable cause, search and seizure, Miranda rights, traffic laws, narcotics, and gangs.

The participants also attended field trips to the Sheriff's Communications Center (SCC) and toured the Century Regional Detention Facility (CRDF) in Lynwood, CA. Upon completion of the program, every participant receives a "Certificate of Participation".



In 2010, we held our 5th Community Academy class at Saint Albert the Great parish located at 804 E. Compton Blvd., Compton, CA 90220. The program had tremendous success graduating one of the largest Community Academies to date in the City of Compton.

FIGHT AGAINST PROSTITUTION

In order to address the long standing prostitution problem along Long Beach Boulevard, Compton Station has engaged in many enforcement measures which have resulted in the arrest of many prostitutes and solicitors of prostitution.

We have partnered with our Major Crimes Bureau targeting prostitutes on Long Beach Boulevard. We have established a Business Watch group specifically for the businesses along Long Beach Boulevard, providing them with comprehensive information to assist them with protecting the investment.

Lastly, we submitted a detailed plan, Crime Prevention through Environmental Design (CPTED), to the City Manager's Office outlining the importance of instituting a comprehensive redevelopment plan.

Even with these aggressive enforcement measures, the problem of prostitution continues to plague the city. To this end, Compton Station in conjunction with our Clergy Council and the local churches initiated prostitution enforcement in which after being arrested for loitering by Community Relations Deputies and Reserve Deputies, the prostitutes are taken to a command post where they are being offered alternatives by the local Clergy Council and local churches, before being booked or cited out.

In recent months, several prostitutes have accepted the assistance offered by the local Clergy Council and local churches and moved away from the streets and the life prostitution offers.

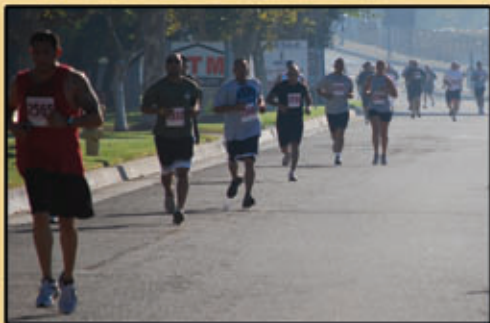
2010 Mug Run

What to do if stopped by a Deputy

BEING STOPPED BY A DEPUTY SHERIFF CAN BE UNCOMFORTABLE. DEPUTIES SHARE YOUR FEELINGS. MORE THAN HALF THE CALIFORNIA PEACE OFFICERS KILLED IN THE LINE OF DUTY WERE CONDUCTING PEDESTRIAN OR TRAFFIC STOPS. OUR BIGGEST CONCERN IS SAFETY, YOUR AND OURS. THE INFORMATION HEREIN WILL HELP EVERYONE GET HOME SAFELY.

WHY DEPUTIES CONDUCT STOPS

Public safety is the primary reason for any stop, for example:

Q: Did you commit a traffic violation?

- Ran a red light, ran a stop sign, expired registration tags, etc.

Q: Was your vehicle or one like it used to commit a crime?

- ADW, arson, kidnapping, etc.

Q: Did you witness a crime?

- Robbery, shooting, burglary, assault, arson, etc.

Q: Do you match the description of someone wanted for a crime?

- Assault, theft, homicide, etc.

Q: Is your vehicle safe to operate?

- Broken taillight, cracked windshield, etc.

Q: Are you ill, do you need sleep?

- Lane straddling, ran red lights, ran stop signs, etc.

WHAT YOU NEED TO KNOW

- Red lights and /or sirens mean pull over to the right where it is safe and where you will not block traffic.
- If it is dark, the deputy will use a bright spotlight or flashlight to illuminate you or your vehicle.
- California law requires all drivers to show their license, registration, and proof of insurance to a peace officer upon request.
- The U.S. Supreme Court states that it is reasonable and legal for a peace officer to ask you and your passengers to exit the vehicle.
- According to state law, if you refuse to sign a citation, you may be arrested.

WHAT YOU SHOULD DO

- Remain in your vehicle and follow the deputy's instructions.
- Keep your hands where the deputy can see them.
- Avoid any sudden movements, and do not reach for your license or other items until the deputy request them.
- Ask any passengers in your vehicle to remain calm and comply with the deputy's instructions.
- Sign the citation if you receive one.
(This does not mean that you are guilty; it is just a promise to appear in court at a later date.)

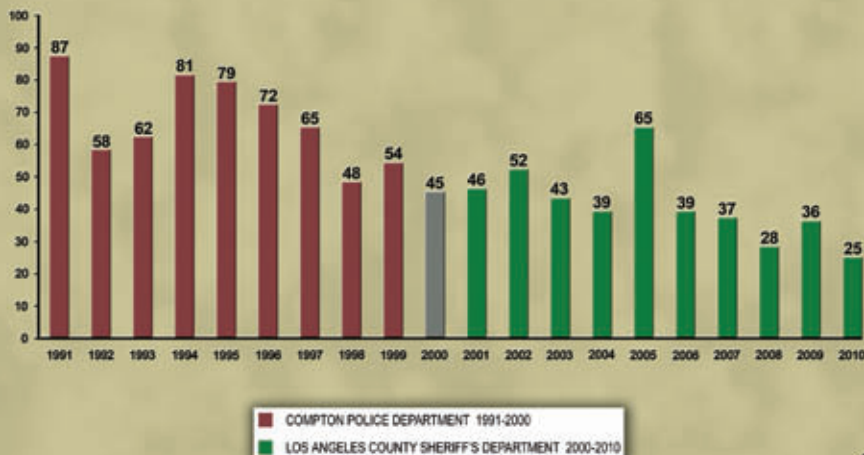
COMPTON HOMICIDES 1991-2010

COMPTON'S HOMICIDES 1991-2010

In January 2009, the City of Compton received national acclaim when its homicide rate for 2008, was made public. The all too familiar Compton story about gang violence and murders, was for the first time in many years overshadowed by a story of hope and progress. Compton reported the lowest homicide rate in over two decades. News outlets such as Newsweek and the Chicago Tribune suddenly published stories on the positive changes Compton has undergone since the turbulent decades of the eighties and nineties.

Again in 2010, Compton enjoyed yet another year of unprecedented success when the murder rate dropped even more. This is largely due to the professionalism and dedication of the men and women of the Los Angeles County Sheriff's Department who have volunteered to serve the community of Compton since the fall of 2000.

The graph below depicts the decline of murders from the period of 1991-2010.
