On Tuesday, August 5, 2014, the communities of La Crescenta, Montrose and La Canada Flintridge are being invited to join forces with thousands of communities nationwide for the 31th Annual National Night Out crime and drug prevention event. National Night Out, which is cosponsored by the National Association of Town Watch (NATW) and co-sponsored locally by Los Angeles County Sheriff's Department Crescenta Valley Station, will involve over 15,000 communities from all 50 states, U.S. territories, Canadian cities and Military bases around the world. In all, over 37 million people are expected to participate in "America's Night Out Against Crime."

National Night Out is designed to: (1) Heighten crime and drug prevention awareness; (2) Generate support for, and participation in, local anti-crime efforts; (3) Strengthen neighborhood spirit and police-community partnerships; (4) Send a message to the criminals letting them know neighborhoods are organized and fighting back.
