This program will focus on the Sheriff Department's operational procedures as well as sessions ranging from criminal law to undercover operations. Participants will go on a ride-a-long, tour a custody facility and participate in a role-playing exercise. The purpose of the Academy is to build a better understanding between the community and the Sheriff's Department through education. The class meets for eleven weeks and it is absolutely free. Classes will be held on Thursday evenings from 6:30 P.M. to 9:30 P.M., at the AERO Institute, 38256 Sierra Highway Suite A, Palmdale Ca.
