REQUEST FOR PROPOSALS (RFP) GENDER-RESPONSIVE REHABILITATION PROGRAM FOR FEMALE OFFENDERS RFP NO. 402-SH

INTRODUCTION

The Los Angeles County Sheriff's Department ("Department"), on behalf of its Correctional Services Division, Offender Services Bureau, is issuing this Request for Proposals (RFP) to solicit Proposals from potential contractors to provide a recurring Gender-Responsive Rehabilitation Program for Female Offenders (GRR Program) with the intent of creating a framework that understands the path to criminality for female offenders, with the overarching goal of promoting female offenders' successful rehabilitation and reintegration into society thus reducing recidivism. This GRR Program will be incorporated into an already existing program dormitory at the Department's Century Regional Detention Facility (CRDF).

Interested and qualified proposers that can demonstrate their ability to successfully provide the solicited services are invited to submit proposal(s) provided they meet all Minimum Mandatory Requirements and contractual requirements.
