BULLETIN NUMBER 2 REQUEST FOR STATEMENT OF QUALIFICATIONS NUMBER 451-SH JAIL OUTPATIENT ORTHOPEDIC CLINIC (JOOC) SERVICES QUESTIONS AND RESPONSES RELEASE

This Bulletin Number 2 is being issued to provide responses to written questions that were received by June 15, 2011. The responses are final and become part of the Request for Statement of Qualifications (RFSQ).

Questions (Italic) and Responses (Bold):

- 1Q. Would a California Professional Medical Corporation, which is directed by an M.D. other than an Orthopedist, but comprised of several local Orthopedists in its network, meet the minimum qualifications to respond to this RFSQ?
- 1R. The specialty of the Director of the Medical Corporation is NOT relevant to the Minimum Mandatory Qualification as described in Section 1.4.3 of the RFSQ. The vendor can appoint one of its orthopedists that is Board Certified in Orthopedic Surgery to be the Contractor Medical Director (different from the Director of the Medical Corporation) to meet the Minimum Mandatory Qualification set forth in Section 1.4.3 of the RFSQ, provided the orthopedist meets the other requirements under Section 1.4.3. The vendor must also meet the Minimum Mandatory Qualifications set forth in Sections 1.4.1, 1.4.2, and 1.4.4 to qualify.
- 2Q. Who are the current contractors and what are the current hourly rates?
- 2R. This is a new program for the Los Angeles County Sheriff's Department (Department). There are no current contractors and as such no current hourly rates. Note, however, that the rates sought under the RFSQ are four-hour shift rates, not hourly rates.

- 3Q. What is the expected duration and frequency for these Ortho clinics?
- 3R. Appendix A, Model Master Agreement, Paragraph 5, Work: Approval and Acceptance - outlines how Work Orders will be issued and spells out the specific duration and frequency. It is anticipated that Work Orders will initially be issued for a six-month period, five days per week, and will require one physician for each of the two four-hour shifts per day. Work Orders will be issued as needed based upon the needs of the County. County does not guarantee any minimum amount of business.
- 4Q. Will a Casting Technician be provided by the County?
- 4R. In accordance with Paragraph 7.1 of Appendix B, Statement of Work, County shall provide all needed nursing and support staff for JOOC Services provided on-site at the Department Jail Facilities. Therefore, support staff would include a Casting Technician.

All other Terms and Conditions of this RFSQ remain in effect.
