Notice to Potential Bidders

BULLETIN NUMBER 2 INVITATION FOR BIDS FOR VEHICLE TOWING AND LONG-TERM STORAGE SERVICES INVITATION FOR BIDS NUMBER 528-SH

This Bulletin Number 2 is being issued to (a) restate Section 1.4 (Bidder's Minimum Mandatory Requirements) to correct Bulletin Number 1; and (b) revise Section 2.3 (IFB Timetable). The following revisions related to the Bidder's Minimum Mandatory Requirements and to the IFB Timetable shall be incorporated into and become a part of the IFB.

1. Section 1.4 (Bidder's Minimum Mandatory Requirements) of the body of the IFB, is restated in its entirety as follows:

1.4 Bidder's Minimum Mandatory Requirements

Interested and qualified Bidders that can demonstrate their ability to successfully provide the required Services outlined in Appendix B (Statement of Work) of this IFB are invited to submit Bids, provided they meet the following requirements.

- 1.4.1 Bidder must have at least five (5) continuous years of experience, within the last ten (10) years, providing Services equivalent to the Services identified in Appendix B (Statement of Work) of this IFB. At least two (2) of the five (5) continuous years of experience must have been providing Services equivalent to the Services identified in Appendix B (Statement of Work) of this IFB to a law enforcement agency.
- 1.4.2 Bidder must have an office and storage facility for Services provided under the Agreement located within a twenty (20) mile radius of the Department's Headquarters Building, 4700 Ramona Boulevard, Monterey Park, CA 91754.
- 1.4.3 Bidder's storage facility for Services provided under the Agreement must have the capacity to store up to 300 vehicles, additional parts and/or equipment, and be secured as described in Appendix B (Statement of Work), Section 3.0 (Storage Specifications and Security Requirements) of

- this IFB. A site visit of Bidder's storage facility will be conducted to verify Bidder meets this requirement.
- 1.4.4 Bidder must have all required licenses and permits listed in Appendix D (Required Forms), Exhibit 15 (Required Licenses and Permits) of this IFB.
- 2. Section 2.3 (IFB Timetable) of the body of the IFB, shall be deleted in its entirety and replaced with the following:
